PSI U ALIVE AND WELL FOLLOWING HOUSE SALE

We apologize for the long delay since our last *Psi News*. Our preoccupation with the lawsuit and our lack of funds available to publish the newsletter were two of the reasons for the unfortunate delay.

As you can read from the letter from the undergraduates on page two, the chapter is very much alive and well. With 35 undergraduate members and 15 pledges, it continues to function and carry on the Psi Upsilon ideals that we all cherish. The other society alumni leaders report that, in spite of the limitations placed on them by the college, both fraternities and sororities remain an important part of the Hamilton College campus environment.

As you know from the proxy you received some time ago, Hamilton Col-

lege settled the lawsuit with Psi Upsilon, Deke, and Alpha Delt. As of this writing, only Sigma Phi remains in the lawsuit. The voting results as determined by the proxies were overwhelmingly in favor of selling the house to the college in return for concessions made by them to assist the chapter in fulfilling its role as a positive contributor to Hamilton student life. These concessions (all requested in the initial stages of the lawsuit and denied by the college) were as follows:

- A dedicated meeting space to be assigned permanently to the chapter and large enough to hold meetings and display chapter memorabilia.
- An option granted to the chapter to purchase two acres of land on Campus Road to build a fraternity house in the event that the college administration changes its position regarding the issue of fraternities owning and using their property.
- An opportunity for the chapter to have, periodically, a common meal where the brothers would eat together

in one sitting.

 Storage facilities provided by the college at no cost to the chapter for memorabilia.

As part of the agreement, we donated \$100,000 of the proceeds to the trustees of Hamilton College to be used for scholarships for deserving Psi U undergraduates. Also, partly because of the awareness created by our actions, Hamilton has just completed a new facility to be used by Hamilton students for social gatherings. This was badly needed since the closing of the fraternity buildings denied students adequate social space on campus.

The selling price of the house was \$460,000. After the scholarship donation and after paying off our mortgage, three-plus years of property taxes, legal bills, loans from several brothers, and any overdue bills, the chapter has about \$65,000 to invest. We will be putting this money in a conservative vehicle and will use any income to help pay our insurance, alumni newsletters, and costs of the Psi U convention.

A very special thank you must go to Jeff Hawkes '80 and his associate, Bob Carey, for handling the legal aspects of the closing at a nominal cost to the chapter. Another thank you goes to Hamilton's vice president of administration and finance, Dan O'Leary, for the gentlemanly way he conducted the negotiations on behalf of the college. And, of course, special kudos goes to Frank O'Brien '58 for his direction and assistance throughout the long legal process.

Enclosed is your annual dues reminder. It is most important that the alumni show their support of the under-


graduates as they strive to keep our chapter one of the strongest on the hill. Your dues show that support.
